DID YOU KNOW: FEVER OF MULTIVITAMINS

Have you ever considered taking multivitamin supplements? Taking right now? Well, that is indeed a good sign, indicating that you are health conscious, unless you know how to take them in the right way. Nowadays, every educated, health conscious person seems to know the importance of these 'Vital Amines' for a healthy life , and people are taking them quite seriously. (There are exceptions!) But, better be careful in pregnancy and lactating periods.

- Many multivitamin products contain minerals like calcium, iron, magnesium, zinc. Excess of these may cause side effects ranging from tooth staining and increased urination, to grave problems like stomach bleeding, mental confusion, and general weakness and indisposal. Hence, it is essential that the prescribed dose-regimen be followed.
- Contact your doctor if overdose is suspected. Overdose of Vit. A, D, E, and K may lead to serious consequences.
- Symptoms may include stomach pain, vomiting, diarrhea, constipation, loss of appetite

hair loss, peeling skin, tingly feeling in the mouth, and changes in menstrual periods, weight loss, severe headache, muscle or joint pain, blood in urine,easy bruising & bleeding, etc.

Avoid taking these pills with milk or dairy products, calcium supplements, or calciumcontaining antacids. It may hamper the absorption of some ingredients in the multivitamin supplements.

SCOPE OF PHARMACY-GOVERNMENT SECTOR

DRUG INSPECTOR

Drug regulation is an important aspect of providing safe, reliable and quality healthcare to the citizens of any country. In India, this task is carried out under the aegis of the Central Drugs Standard Control Organization (CDSCO)-India, which constantly requires skilled and competent officers to discharge and oversee these duties on its behalf. This is the role of Drug Inspector-India comes into the picture.

EMPLOYED BY:

Central Drugs Standards Control Organization (CDSCO), Ministry of Health & Family Welfare, Government of India.

SCOPE

The above-mentioned designation falls under the purview of the Government of India and offers all the facilities and perks of being a government official.

At the same time, with the Indian government looking to strengthen its Drugs Inspection process, amid talks held last year, the numbers of vacancies for the post of Drug Inspector-India are expected to rise five fold in the coming years, thus promising favourable employment opportunities to young pharmacy professionals.

ELIGIBILTY

1.AGE

Not exceeding 30 years as on normal closing date for General Candidates. Relaxable for regularly appointed Central/UT Govt. servants upto five years in accordance with the instructions or orders issued by the Govt. of India.

2. ESSENTIAL QUALIFICATION (S)

(A) EDUCATIONAL:

The candidate must possess a Degree in Pharmacy or Pharmaceutical Sciences or Medicine with specialization in Clinical Pharmacology or Microbiology from a recognized University or equivalent.

(B) EXPERIENCE:

(i) The candidate must have at least 18 months' experience in the manufacture of at least one of the substances specified in Schedule 'C' to the Drugs and Cosmetics Rules, 1945 or

(ii)The candidate must have at least 18 months' experience in testing of at least one of the substances specified in Schedule 'C' to the Drugs and Cosmetics Rules, 1945 in a laboratory approved for this purpose by the licensing authority or

(iii)The candidate must have at least 3 years' experience in the inspection of firms manufacturing any of the substances specified in Schedule 'C' to the Drugs and Cosmetics Rules,

1945 during the tenure of their service as Drugs Inspector.

These regulations may be relaxable under certain circumstances.

EXAMINATION

The examination is conducted by the Union Public Service Commission. The test is an objective-type exam, of two hours duration and the medium of the test is English only.

Basic: Rs.9300-34800 plus Rs. 4800/-

Grade Pay (Total emoluments Rs. 37,571/- (Rs. 13,350 G.P. of Rs. 4800 107% D.A. as on 0107.2014)



DUTIES:

Duties and functions specified in Rules 51 and 52 of the Drugs and Cosmetics Rules, 1945 include inspection of

- All licensed drugs manufacturing establishments
- The plant and the process of manufacture, the means employed for standardizing and testing the drug, the methods and place of storage, the technical qualifications of the staff etc. which are likely to affect the potency or purity of the product, taking samples of drugs from premises of manufacturer/ dealers for test or analysis,
- Investigation of cases of spurious drugs and related complaints
- Launching of prosecutions for breaches of the Drugs and Cosmetics Act, 1940 and Rules.
