NEWS & EVENTS



1. This year also we at AISSMS College of Pharmacy Kennedy Road, Near R.T.O. Scheme concludes by February end of each academic year.

DID YOU KNOW: Dangers of NSAIDs



Nonsteroidal anti-inflammatory drugs (NSAIDs) are a drug class that groups together drugs that reduce pain, decrease fever and in higher doses, decrease inflammation. The term nonsteroidal distinguishes these drugs from steroids, which, among a broad range of other effects, have a similar eicosanoid-depressing, anti-inflammatory action. The most prominent members of this group of drugs are aspirin, ibuprofen and naproxen etc. The use of these NSAIDs frequently may lead to risks.



1.Increased Risk of Heart Failure-

Research published in the British Medical Journal found that NSAIDs increase the risk of heart failure by an alarming 19%.

2.Gastrointestinal Damage, Ulcers and internal Bleeding-

NSAIDs all share the same most prevalent side effect: damage to the gastrointestinal tract, which doesn't just mean your stomach- it also includes possible to your esophagus and small intestine.

3.Higher Risk of Renal Failure-

The most common renal complication caused by

NSAIDs is fluid retention, which is believed to occur on some level in anyone taking these man-made anti-inflammatory pills.

4.Serious Allergic Reactions-

Some people are actually highly allergic to NSAIDs

5.Dangers to Children and Teenagers-

The use of aspirin by children and teenagers with chickenpox or the flu has been associated with chickenpox or the flu has been associated with the development of Reye's syndrome

Mr. Harshad Agre is working as a Director – Global Project Management, with Syneos Health with around 16 years experience in the clinical research industry. It's a multinational Contract Research Organization with more than 21 thousand employees working across 47 countries. As a Director in the Global Project Management, he oversees clinical development projects running across the globe. He is responsible for ensuring immaculate quality in all



project deliverables meeting timelines and ensuring profitability. He does manage hundreds of people distributed across more than 30 countries. Mr. Harshad Agre has completed his schooling and graduation from Solapur, Maharashtra, India. During B. Pharmacy, he was felicitated with many awards for securing highest percentage of marks in India and securing first rank in the University. 1. How did you break into the field you are in today?

I always wanted to be in marketing whilst studying pharmacy. However after spending around 18 months with GSK, I realized that it wasn't my cup of tea. Then, I planned my career strategically. An opportunity knocked from Emcure to work in this

interesting field. When I started working in Clinical Research, most of the people around me didn't understand what I was into. Being a small department and having few resources at Emcure, I was shouldering lot of responsibilities including, Protocol Writing, ICF Writing and Translations, Case Report Form Designing, Regulatory aspects of a study, Monitoring, Data Entries and analysis using various statistical tests, report writing and publications. The list may go on. However, when I look back, I consider those were the years which helped me build a strong foundation for my career. During my first few years there, I realized hard work pays you off.

2. What are the most interesting and/or current developments in your field?

Most of us aren't cognizant of the duration for getting a new drug in the market. Hundreds of potential molecules are whittled down to get one molecule that enters clinical phase of development. At this stage too, few molecules face attrition and are knocked off due to safety or efficacy aspects. Working in the clinical research field allows me to be aware of newer trends in treating various diseases which may hit the market after a decade or so. Because of confidential nature of work, I may not be able to disclose the newer line of treatments we are currently assisting to develop..

3. Given the current circumstances, what do you feel about pursuing higher studies in the Healthcare field in a foreign country i.e. USA, Canada etc.?

Higher education anywhere may be helpful, however it should interest one. Our universities for higher education are also equally respected across the industry. I feel, at the end of the day, hard work, consistency and willingness to learn would matter more than anything else. But, if you are interested in pursuing higher education, you should live that thought every moment of your life until the goal is achieved.

4. What kind of opportunities does the Indian market promise as compared to foreign markets e.g. North America/Europe?

For Clinical Research, our industry is not as developed as the Japanese or western countries in terms of developing a New Chemical Entities and conducting clinical trials. However, in the recent past, our industries are gearing up with conducting clinical trials for Biosimilar drugs and marketing the same in the globalmarket as generic. I am sure, with more companies seeking US FDA approvals, things are turning very positive on those fronts.

5. Do you believe it is a good time to start up on your own- here in India? Or do you suggest the job security of a conventional 9-5 job?

The word job security doesn't exist and also for professionals like us a 9 to 5 job would be a dream. Rather, I would suggest we shouldn't restrict ourselves to such limitations. Starting your own set-up completely depends on individual interests. If you have made up your mind to start your own set-up don't wait for the right time. It may never come. You should start it based on your own instinct, knowledge and understanding. Whether you are in a job or you have your own set-up, please be patient and consider at least the first 3 to 5 years of your career as an investment. The harder you work and develop yourself during this phase, better you reap later.

6. What is your opinion about young recruits today? What improvements would you suggest?

Today's young recruits are smart, knowledgeable and dynamic. We all are equal. If I can do it, I am sure; anyone can do the same or better. If they want to improve on something it would be bit of patience and focus.

7. We would love to hear what you think about

the Pharmacy course in India. Kindly express your views.

As mentioned previously, no course is good or bad. It's your ability to learn newer things, grabbing opportunities and working hard on the same would fetch you results. Our pharmacy courses are quite good, but we should try to add more hands on experience based on the individual interests. That would give a cutting edge to our students.

8. What is your message to young graduates/postgraduates in Pharmacy...

Keep rocking, have fun during your college time, but never lose focus. Believe in your ideas, believe in yourself and do everything to achieve your goal and remember to enjoy the journey too.

9. Is there anything else you would like to share with us?

If you see any successful person around, don't see what he / she is today. What you see is the tip of the iceberg. But the real success lies beneath and for that you have to dive deep to understand the hard work they have put in. This is an awesome initiative by you and I take this opportunity to wish you all every success in whatever you do. Keep following your dreams.
