## DID YOU KNOW: LYCOPENE: YOUR WAY TO A VERSATILE NUTRIENT!!!



**Lycopene** known widely as the "red carotenoid" is found orange-reddish coloured fruits like, carrots, grapefruits, pink guava, watermelon, red papaya, peaches, apricots, and in tomato as well as its byproducts like ketchup, juice, paste, etc. The highest amount of lycopene was found in tomato paste 30.07 mg per 100 gm. Lycopene being a lipophilic nutrient gets absorbed and has higher bioavailability. Research conducted by American health bodies suggested numerous health benefits as follows:

1. Antioxidant: The bioactive metabolite of lycopene is efficient 10 times fold in quenching of free radicals which promote higher risk of cardiovascular due to oxidative stress. It was found that daily

consumption of minimum 15mg lycopene acts as an effective in vivo antioxidant.

- 2. Anticancer: The lycopene inhibits cell cycle of cancerous cells. The progression from G0/G1 phase to S phase is stopped by inhibition of cyclin D1 protein which is key regulator in the process. It 5. Alzheimer's disease: Prevents memory loss and also reduces the insulin like growth factor seizures in old age diseases. risk of breast and prostate cancer.
- 3. Regulation of transcription: The transcription is process of transfer of genetic information from 7. Reduction in neuropathic pain cellular pathways and this is due to either cholesterol interaction of carotenoid molecules or derivatives with transcription factors like ligand activated nuclear receptors or changes in cellular redox levels affecting redox sensitive transcription systems.
- 4. Skin protection: Oral sun protectants are seen as more efficient than topical sunscreens and prevent skin damaging on daily basis and not only in specific time period like summers. The UV radiation directly after contact with the skin layer induces tanning, skin cancer, burns, inflammation, redness, premature aging of skin. Lycopene being

a scavenger for radicals mitigates the photooxidative skin damage. Lycopene also brings a healthy glow to the face and cleanses thoroughly any dead cells when used in masks or consumed raw.

### 10. What is your message to young graduates/postgraduates in Pharmacy ...









