Manual For Admission Procedure

- 1. After preparations of documents please go to the website i.e. admission.aissms.org
- 2. Click on 'Sign up' button.
- 3. Fill your personal details & click on 'Create' button.
- 4. Next you will get the admission form, fill all information in details and upload the documents as per the category requirements.
- 5. Submit the form and take the photo or note down the student code for further process.
- 6. The form will be send to the approval through online process, he/she will be approved the form
- 7. Submit Printout of the form along with signature of student and parent in the Room No: 214.
- 8. After approval of the approver fee payment option will be open in student login.
- 9. For student login –use website : erp.aissms.org
- 10. Student can login to website: erp.aissms.org through student Code as user name & password.

- 11. Change your password and go to the fee and select online payment option and pay the fees.
- 12. After payment go to the room No. 214 and meet Mr. Ajay Kolambe for submission of admission form and confirmation on CET Website.

GENERAL ADMISSION GUIDELINES FOR B. PHARM. & M. PHARM.

- 1. In the State of Maharashtra, all admissions are done through Centralized Admission Procedure on the basis of MHT-CET/NEET score which is conducted by Government of Maharashtra, State Common Entrance Test Cell, Mumbai.
- 2. The centralized admissions are done by Government of Maharashtra, State Common Entrance Test Cell, Mumbai, having website www.cetcell.mahacet.org.
- 3. The Competent Authority conducts Maharashtra State Common Entrance Test (MHT-CET) for the candidates.
- 4. Every student (Maharashtra State / OMS / All India Level Candidates) seeking admission to B. Pharm course must have appeared for MHT-CET/ NEET.
- 5. The MHT-CET 2025 brochure has been published and is available on the website www.cetcell.mahacet.org.
- 6. The eligible students have to register at Scrutiny Center (SC) allotted by the competent authority and get the original documents verified and have to submit the Xerox copies of documents at SC.
- 7. The inter-se-merit list is published on the website by competent authority on the basis of MHT-CET score.
- 8. All types of candidates seeking admissions to B. Pharm under CAP must register and get documents verified at designated SC including Institute Level admissions.
- 9. Students have to fill the Options online or at SC through their login.
- 10. The provisional allotment of CAP is displayed on website as per the schedule published.
- 11. The competent Authority conducts the specified admission rounds.
- 12. The candidates report to allotted Institute and confirm the admission along with original documents and fees.
- 13. For admission to M. Pharm course, student must have appeared for the GPAT 2025.

- 14. The merit list for M. Pharm is prepared on the basis of GPAT score.
- 15. Admissions of M. Pharm are done by Competent Authority through online CAP rounds.
- 16. The Direct S. Y. B. Pharm. admissions are also made by (CAP) as above.
