

Have a safe summer!

Summer is our favourite season, for there are holidays and lot of hiking, beach camping attracts everyone. So much enthusiasm we have towards outdoor trips that we may forget to take care of our health, especially our skin, which faces the rage of sun and gets tanned. Here is where the sunscreen products come into picture.

WHAT ARE SUNSCREEN LOTIONS AND WHY ARE THEY DIFFERENT?

Sunscreen products are specially designed for protection of skin from harmful radiations of sun, to be precise, UVA and UVB radiations. They are different because they have different friendly organic and inorganic substances which coat our skin from these radiations. Also, special care is to be taken while selecting and applying these products. Here is where they earn their respect.

WHY SOULD ONE USE SUNSCREENS?

They are necessary since the harmful radiations which can otherwise cause skin cancer, sun burns, tans are kept away from the skin.

WHAT IS TANNING?

Tanning is the secretion of melanin pigment by skin to absorb/reflect the UV radiations falling on skin. Actually, tanning of the skin itself indicates that the skin is getting damaged and it is trying to protect itself.

WHICH SUNSCREEN PRODUCTS SHOULD ONE CHOOSE?

The one which has high SPF (Sun protection factor), and has 4 to 5 UVA Stars. SPF is the measure of the product to which it gives protection against the UV radiations. Generally SPF 30 is considered sufficient.

WHAT IS SPF AND UVA STARS?

SPF shows the level of protection against UVB radiations. UVA stars give the percentage of UVA radiation absorbed in comparison with UVB.

ARE MOISTURIZERS GOOD SUNSCREENS?

Moisturizers are having SPF around 15 but this may not be sufficient if sun is too intense. Moreover, the composition and amount used of moisturizers do not allow them to form a layer thick enough to perform as an efficient sunscreen.

HOW TO USE SUNSCREENS?

Since different brands introduce different forms of applications, it is up to them to guide the customer on proper use. But generally, they are to be applied judiciously over every inch of exposed skin, and a thick layer of product should remain on skin for moderate time interval.

- Apply before going out in the sun and after going out to make sure no patch is left exposed.
- Reapply after swimming since towel drying removes the 85% of product layer.
- Reapply after every 2 hours.

It is necessary however, to consult your pharmacist, or healthcare professional before choosing your product since requirement of every person is different.

SCOPE OF PHARMACY-GOVERNMENT SECTOR:



PHARMACIST

The position of pharmacist is the most well known position in the entire field of pharmacy. Most of us are familiar with pharmacists in the retail setting. However, it is worth noting that the government sector, too, provides a whole host of opportunities in this regard.

The various job opportunities available are as a pharmacist-technician, pharmacist-assistant, pharmacy clerk, pharmacy dispenser, pharmacy supervisor, pharmacy intern, pharmacy technician trainee and pharmacy manager.

These positions are available as part of

- 1. Central Government Health Scheme (CGHS)
- 2. Ex-Servicemen Contributory Health Scheme (ECHS)

They are also available at reputable government institutes and Public Sector Undertakings (PSUs) like:

- 1. All India Institute for Medical Sciences (AIIMS), New Delhi.
- 2. Post graduate Institute for Medical Sciences (PGIMER), Chandigarh
- 3. National Institute for Research in Tuberculosis, Chennai

and so on.

In this issue, we will look at the various eligibility requirements for the post of Pharmacist (Allopathy) in the Central Government Health Scheme (CGHS).

EMPLOYED BY

The Directorate of The Central Government Health Scheme, New Delhi under The Ministry of Health and Family Welfare, Government of India. **ELIGIBILITY:**

Age Limit:

Candidates' age limit should be between 18 – 25 years as on last date for receipt of application. Age relaxation is applicable up to 40 years for Government Servant in case of general candidates and 45 years for SC/ ST candidates.

Educational Qualification:

Candidates should be

1. Class 12 pass with science subjects (physics, chemistry and biology) or equivalent from recognized board or university

2. Diploma in pharmacy from recognized institution and registered as pharmacist under the pharmacy act, 1948 with 2 years experience as pharmacist in any recognized hospital or pharmacy after duly registered as pharmacist under the Pharmacy Act 1948.

Or

Bachelors degree in Pharmacy (B. Pharm.) from a recognized university or equivalent, registered as a pharmacist under the Pharmacy Act, 1948.

Experience:

Candidates must have a minimum of 2 years experience as pharmacist in any recognized hospital or pharmacy after duly registered as pharmacist under the Pharmacy Act, 1948. Knowledge of computers is desirable, as most of the CGHS operations have been computer-

Examination/Application:

Candidates are selected based on an examination followed by an interview, conducted by the state branch of the CGHS. Eligible candidates may apply online through the official state websites of the CGHS and must send the hard copy of duly filled in application along with self attested documents, Demand Draft should be sent by post to the Office of the Additional Director, Central Government Health Scheme (CGHS) of the concerned state.

DUTIES

1. Maintenance of the Pharmacy records, indenting medicines, summarization and postings in the relevant stock registers

2. Indenting and proper storage of the medicines needed for the use in the Pharmacy

3. Performing the duties of the Sr. Pharmacist & Store Incharge in his absence

4. Any other duties as assigned from time to by the administration.

PAYSCALE

The payscale, as revised and approved as per the 6th Pay Commission is as follows:

Pharmacist (Entry Grade): Grade pay of Rs 2800 in pay band-I

Glaxo was founded in the 1850s as a general trading company in Bunnythorpe, New Zealand, by a Londoner, Joseph Edward Nathan.[11] In 1904 it began producing dried-milk baby food, first known as Defiance, then as Glaxo (from lacto), under the slogan "Glaxo builds bonny babies."The Glaxo Laboratories sign is still visible (right) on what is now a car repair shop on the main street of Bunnythorpe. The company's first pharmaceutical product, produced in 1920, was vitamin D.

In 1924 Galxosmithklines was established.Glaxo Laboratories opened new units in London in 1935. The company bought two companies, Joseph Nathan and Allen &Hanburys in 1947 and 1958 respectively. In 1999 the company was the world's largest manufacturer of drugs for the treatment of asthma and HIV/AIDS.It employed 59,000 people, including 13,400 in the UK, had 76 operating companies and 50 manufacturing facilities worldwide, and seven of its products were among the world's top 50 best-selling pharmaceuticals. The company had R&D facilities in Hertfordshire, Kent and London, and manufacturing plants in Scotland and the north of England. It had R&D centres in the US and Japan, and production facilities in the US, Europe and the Far East.





GSK's drugs and vaccines earned £21.3 billion in 2013. Its top-selling products that year were Advair, Avodart, Flovent, Augmentin, Lovaza and Lamictal.
